First Cause for Discipline:

I respectfully disagree with the citation under Section 19275, subdivision (b), as neither myself (Andrey Vox, AV) nor my son (Vladislav Vokhmyakov, VV) ever operated or advertised SAFM. The domains Safenfastmovers.com and safeandfastmovers.com were registered over 10 years ago for the sole purpose of my business, Safe N Fast Movers, and the associated Facebook page was created over six years ago. SAFM, on the other hand, was registered on November 5, 2021, but remained dormant until it was terminated on March 6, 2023, without ever being activated or operating. I have provided documentation from my bookkeeper, Professional Accounting Concepts, confirming that SAFM never earned income or operated. A copy of this letter is attached for your review.


The decision to create SAFM was initially made because my son, Vladislav, intended to join the moving business and had successfully passed the Household Goods Carrier Permitexam. Unfortunately, we were unable to activate SAFM due to the BHGS requirement for commercial liability and cargo insurance, which an insurance provider was unwilling to issue without purchasing a truck for SAFM. As we did not have the funds to acquire a truck, Vladislav ultimately decided to pursue higher education instead, and SAFM was terminated, as there was no longer any need for it. Throughout this period, I continued operating my sole proprietorship, Safe N Fast Movers, with no intention or reason to activate SAFM.

Second Cause for Discipline:

No cause for discipline exists under this section.

Third Cause for Discipline:

I acknowledge my lack of awareness regarding the requirement to display a link to the BHGS website on my business website. I had always ensured that my MTR PUC number was prominently displayed so that customers could verify my business. Upon learning of this requirement last year, I immediately took action and added the link to the BHGS website to the top section of my website.

Fourth Cause for Discipline:

I respectfully contend that I have not violated Section 19279.3, subdivision (b), as I never knowingly or wilfully advertised SAFM. Since I was operating as a sole proprietor under Safe N Fast Movers, there was no reason or intention to advertise SAFM, which was never activated. The business number assigned to SAFM, 949-331-3002, was never used or advertised. Furthermore, SAFM did not have a web page as its permit was never activated.

Fifth Cause for Discipline:

This case seems to be based on a misunderstanding, as I have provided a detailed explanation demonstrating that SAFM never operated or was advertised. I request that this case be reopened and reconsidered in light of the evidence presented.

Case HHM-191, OAH # 2024090174:

In line item 25, it is stated that Mr. Manila called the SAFM business number and received a quote for a move from SAFM. This is not possible, as I have stated that the phone number associated with SAFM was never utilized. When asked during the hearing, Mr. Manila could not confirm which number he dialed. If he did call, it must have been Safe N Fast Movers' sole proprietorship number, 949-331-6262, from which he would have received a quote only for Safe N Fast Movers. Any written quote would also have been sent from safenfastmovers@gmail.com. This evidence clearly demonstrates that I only operated under my sole proprietorship, Safe N Fast Movers, which is verifiable through call records from Ring Central.

Furthermore, in line item 25, it is mentioned that evidence shows images were generated from SAFM's URL. However, I would like to clarify that the URLs Safenfastmovers.com and safeandfastmovers.com have been associated with my sole proprietorship for over 10 years and were never connected to SAFM. The assertion that these URLs belong to SAFM is inaccurate.

Mr. Manila may have mistakenly perceived a potential transition of my sole proprietorship's structure into SAFM, which would have occurred only if my son chose to enter the moving business and the SAFM MTR permit was activated. However, this never took place, as SAFM was terminated well before Mr. Manila began his investigation. For example, Mr. Manila's visit occurred on April 28, 2023, while SAFM was already terminated on March 6, 2023.

I deeply respect the work that BHGS does to protect consumers and moving companies like mine, and I am grateful for their role in the industry. I also acknowledge my oversight in not being aware of the requirement to include the link to the BHGS website and am willing to accept responsibility for this mistake by paying the necessary fine. However, I maintain that I am not guilty of knowingly or wilfully advertising SAFM, as there was no reason or financial gain associated with its promotion.

I am open to answer any questions or provide clarifications you may have to reinstate the real situation associated with these cases. Should we need to schedule an online meeting, please advise on your earliest availability.

I kindly request BHGS to reconsider my permit suspension and, if I must pay the fine, to allow for an extended payment plan. Without the ability to run my small moving business, I would face severe financial hardship. Please review my letter and let me know your decision.


