FINDINGS OF FACT

1. On or about August 27, 2024, Complainant Justin Paddock, in his official capacity as the Bureau Chief of the Bureau of Household Goods and Services, Department of Consumer Affairs, filed Accusation No. CM 2023-427 against Brian Yousofi doing business as Computer World (Respondent) before the Director of the Department of Consumer Affairs (Director). A copy of the Accusation is attached as Exhibit A.

2. On or about December 24, 2007, the Bureau of Household Goods and Services (Bureau) issued Electronic Repair Registration No. E-83891 to Respondent. The registration expired on December 31, 2021, and has not been renewed.

3. On or about August 28, 2024, Respondent was served with Accusation No. CM 2023-427.

4. On or about September 6, 2024, Respondent signed and returned a Notice of Defense, requesting a hearing in this matter.

5. On, February 10, 2025, a Notice of Hearing was served by mail at Respondent's address of record which was and is: 37312 Fremont Boulevard, Fremont, CA 94536-3703. The Notice of Hearing informed Respondent that an administrative hearing in this matter was scheduled for July 29, 2025.

4 4. The Director finds that the actual costs for Investigation and Enforcement are
5 \$9,886.00 as of July 29, 2025.

6 **ORDER**

7 IT IS SO ORDERED that Electronic Repair Registration No. E-83891, issued to Brian
8 Yousofi doing business as Computer World, is revoked.

9 Pursuant to Government Code section 11520, subdivision (c), Respondent may serve a
10 written motion requesting that the Decision be vacated and stating the grounds relied on within
11 seven (7) days after service of the Decision on Respondent. The agency in its discretion may
12 vacate the Decision and grant a hearing on a showing of good cause, as defined in the statute.
