Pursuant to the statutory provisions of Business and Professions Code sections 19279, 19279.1, 19279.2, 19280 and 19281 of the Household Movers Act, the administrative fine for the above cited violations is as specified on the Contact Report (CR) provided:

Your assessment is based on a violation of the Business and Professions Code as stated above.

You may, within ten (10) days after service of the citation, notify the Bureau Chief in writing of your request for a citation review conference with the Chief or his or her designee regarding the acts charged in the citation.

Additionally, if you do not request a citation review conference within the prescribed time period, you may still request an administrative hearing in accordance with Business and Professions Code sections 125.9 and 19268. A request for a hearing shall be delivered in writing to the Bureau Chief at the address listed above within 30 days of the date of issuance of the citation.

Please take notice that a request for a citation review conference does not extend the thirty (30) day time period to request a hearing before an administrative law judge. You may proceed directly to an administrative hearing without participating in a citation review conference before the Bureau Chief or his or her designee.

Failure to request a citation review conference, an administrative hearing, or both, shall cause the original citation to be considered the final order of the Bureau, and not subject to further administrative review or appeal. If you do not request a citation review conference or hearing, payment of the fine does not constitute an admission of the violation charged.

Issuance of a citation may be subject to public disclosure, in such forums as the Bureau's website and newsletters, or in response to a Public Records Act request. Notwithstanding any other provision of law, if a fine is paid to satisfy an assessment based on the finding of a violation, payment of the fine shall be represented as satisfactory resolution of the matter for purposes of public disclosure. Failure of a licensee to pay a fine within 30 days of the date of assessment, unless the citation is being appealed, may result in disciplinary action being taken by the Bureau.
