On May 04, 2017, CR-73217: a Bureau inspector picked up 3 mattresses for laboratory testing. Product procurement form provided to business. Dreamer E/TOP \$232.00; R/R bed \$651.00; Prelude T/TOP \$175.00; total \$1,061.00. SR 28480.

On May 11, 2017, CR-73220: The inspector returned the 3 mattresses picked up on May 04, 2017, because they had incorrect registry numbers on the labels. The owner is now aware of the problem and will replace all product labels that have incorrect registry numbers. The Bureau Inspector picked up 3 mattresses with different prototype ID numbers. No citation was issued.

On May 22, 2017, the lab completed analysis 0085-2017 on Twin mattress (2) R/R bed; PTID 632312; model TT11. Results: Fail 16CFR 1633; Fail label format.

On May 23, 2017, the lab mailed to you a letter titled "LABORATORY TEST RESULT NOTIFICATION AND PRODUCT NON-REIMBURSEMENT", informing you of the flammability failure and label discrepancies.

# Order of Abatement:

Immediately Cease and Desist from Manufacturing, Importing, Wholesaling, or Retailing, the above mentioned item for sale to California consumers - until you have shown to the Bureau's satisfaction you are compliant:

- With all laws and regulations set forth in the Home Furnishings and Insulation Act;
